The assigned manager will be promptly informed by the team and will follow up with you as necessary on the matter.



HOW DO I PAY MY MAINTENANCE FEES?

Condominium Associates offers several ways to make your monthly payment including ACH, check, e-check, or credit card. A payment coupon book will be mailed to your attention shortly. If you have already made your February 1st payment to Ameritech Property Management, it will be forwarded to Condominium Associates. Instructions for each payment method follows:

By Auto Pay

Complete and return the enclosed Automated Clearing House (ACH) form to start ACH payments for February 1, 2024, in order for your January payment to be made via ACH we will need to have the form completed and returned to us by January 25, 2024. You may email it to us at ar@condominiumassociates.com. There is no charge for this service.

By Check or e-Check (include your account number on the check)

There is no charge for payments sent to the P.O. Box when you include your payment coupon. Pay by check by mailing to the bank lockbox below.


